## Summary

The following document provides information about new features and product improvements added since the release of the SLS Administration Tool (AT) User's Manual version 1.3.0 and up to version 1.8.0.

Recommended PC requirements for AT: Intel Core<sup>TM</sup> 2 Duo Processor 2.66 GHz (or faster) 4 GB RAM Windows® XP or newer Internet Explorer (IE8 or newer) Excel 2003 or greater to open reports

**WARNING:** The use of label colors is intended only as an aid in the identification of drug groups and does not absolve the user from the duty of reading the label and correctly identifying the drug prior to use.

# Version 1.4.0 SLS Administration Tool

#### **New Features**

 The AT now provides the ability to remotely install software updates via wired (i.e., Ethernet) and wireless (i.e., Wi-Fi) networks.

After installing the 1.4.0 AT, start-up the AT and from the AT-DM, select Safe Label System 500i (SLS) Point of Care Stations (PCS) that you want to install software. Next, select Install Software.

**NOTE:** Upgrading the software on SLS PCS will erase the formulary on that system. A new formulary package should be created before upgrading SLS PCS software.

An **Install Software** window will open asking for the user to set the amount of time to delay the install after the time a user logs off SLS PCS. Select **Install**.

**NOTE:** Upgrade via the network does not require removing SLS PCS SmartDrive which is required when performing a manual install.

- The AT now has the ability to select or enter Total Dose (TD) and Total Volume (TV) for a syringe. The TD and TV as well as the equivalent concentration will be displayed on SLS PCS user interface and print on the label. Refer to "Total Dose/Total Volume" on page 19 for complete instructions.
- The AT now supports 80 x 30 mm labels. These labels are typically used for larger syringes (20 mL or larger). Refer to "Localization Enhancements" on page 23 for setting the templates in the AT.

**NOTE:** Make sure that the label template pack that is deployed to SLS PCS is the same as the labels installed. If a small label (48 x17 mm) template pack is deployed to SLS PCS and large labels (80 x 30 mm) are installed, then the printed area on the label will be small.

• The AT now supports 48 x 17 mm labels. These labels are typically used for smaller syringes (10 mL or less). Refer to "Localization Enhancements" on page 23 for setting the templates in the AT.

**NOTE:** Make sure that the label template pack that is deployed to SLS PCS is the same as the labels installed. If a large label (80 x 30 mm) template pack is deployed to SLS PCS and small labels (48 x 17 mm) are installed, then SLS PCS will print outside the small label and ink will be sprayed inside the device.



• The Email Notifier (EN) application is now available as a service with the AT. As a service, the EN can run without being logged into the computer it is running on. The service can be started up and shut down. Refer to the Read Me file included with the EN for setup instructions.

• SLS now provides support for alphanumeric codes up to 13 characters. When Database Mode is set to Other mode in the AT, you can create a rule (refer to "Localization Enhancements" on page 23) and select a barcode symbology that will support alphanumeric codes. After a formulary is created with alphanumeric codes (e.g., 0010-28-061-J) and deployed to SLS PCS, scanning of barcodes with alphanumeric codes is supported.



#### **Product Improvements**

• An automatic installation and automatic migration utility is included with the AT. It is provided to install the 1.4.0 AT and migrate formularies created with formularies prior to 1.4.0 software. It is included on the AT disc and operational instructions are included in the AT User's Manual version 1.3.0.

**WARNING:** Before migrating data, make sure to document settings that will not be migrated (currently custom WAV files). Further migration instructions are provided in Codonics Administration Tool Migration Utility Technical Brief 901-253-002.

- The barcode symbology EAN-13 displayed in the AT is now supported on SLS PCS.
- The barcode symbology Interleaved 2 of 5 in US NDC mode displayed in the AT is now supported on SLS PCS.
- Support is now provided for localization of all concentration units (e.g., Units, Units/mL, etc.).
- The Formulary Verification worksheet in the Formulary Report now lists all the drugs in the formulary and their statuses. Previously, the Formulary Report only displayed the unverified drugs.
- The dilution concentrations in the formulary are now organized the same as the Master Drug Database (MDD). The dilutions are organized by number and then alphabetically by concentration unit.
- SLS support new drug name WAV files. The new drug name WAV files included are Acetylcysteine, Cyanocobalamin, Dehydrated Alcohol, Thiamine, Acetylcholine, Butorphanol, Caffeine, Dalteparin, Enalaprilat, Fat Emulsion, Hepatitis B Vaccine, Insulin NPH, Iodixanol, Iohexol, Lidocaine with Dextrose, Lactated Ringers, Penicillin, Plasma Protein Factor, Sodium Tetradecyl Sulfate, Tetanus Diptheria Toxoi, Augmentin, Cloxacillin, Ergometrine, Esomeprazole, Factor VIII, Glyceryl Trinitrate, Nimodipine, Penicillin G, Pethidine, Somatostatin, Suxamethonium, Tramadol, Heparinized Saline, Adrenaline, and Noradrenaline.
- SLS support new concentration numbers. The new numbers included are 0.064, 0.12, 0.16, 1.875, 4.2, and 12.5.



- The AT and SLS PCS support new concentration units. The new concentration units included are Each, mcg/INH, M Units/mL with the WAV file being Million Units per Milliliter.
- The Lexicomp filters are now alphabetized.
- An additional text color was provided. #890C58 (shade of purple) was added as a text color option in the Custom Template Definition of the AT.

# Version 1.5.0 Administration Tool

### New Features

- The AT now includes JAVA runtime. The computer that is running the AT does not require JAVA to be installed.
- In addition to the traditional label format, SLS PCS now supports labels with an Auxiliary 1-D barcode or labels with a Patient Write-In area on the Standard 22x60mm label (STD-2-v02). Refer to "Auxiliary Barcodes" on page 34 for configuring the label in the AT. The functionality now prints the following labels depending on which of the following options is selected in the AT: a 1-D barcode on the standard label that provides compatibility with legacy BCMA (e.g., MediTech, Epic) and AIMS (e.g., McKesson, DocuSys, GE) systems that read NDC codes.



Alternatively in the AT, you can select to have a blank area print on SLS PCS to write-in information such as patient name.



Or, configure the use of a traditional label format.



- SLS PCS now supports integration with the B.Braun Space pump. B.Braun barcodes can be included on printed SLS syringe labels and then used to transfer data (i.e., drug name, concentration value, and concentration units) to a B.Braun Space pump. A feature key is required to enable this feature. Contact your Codonics Sales Representative to purchase the key. Refer to Codonics B.Braun Technical Brief (901-265-001) for complete instructions.
- SLS PCS now supports variable length container IDs in Other mode. SLS supports scanning and reading of variable-length Container IDs. For example, SLS PCS will now scan a drug container that uses a Data Matrix barcode with a 10-digit Container ID and a different container that uses an EAN-13 barcode with a 13-digit Container ID. Refer to "Variable Length Container IDs" on page 37 for complete instructions for setting up variable length rules in the AT.

**WARNING:** Some barcode parsing rules may not operate properly when minimum or maximum values are changed. This can result in drugs not being found when the container is scanned. Review all barcode parsing rules to ensure drug containers are recognized when scanned.

SLS PCS now supports Named Devices. The network interface(s) on SLS PCS can be assigned dynamic IP addresses by the hospital network. Because the IP address of SLS PCS can change over time, providing a static device name will make it easier to configure the AT and Email Server to communicate with individual units. Each SLS PCS system includes a pre-defined device name that is unique to the Ethernet or Wireless interface on that device. The pre-defined device name(s) are associated with the SmartDrive to allow the device name(s) to remain the same when the SLS PCS is swapped and the SmartDrive is transferred to the new SLS PCS.

NOTE: The pre-defined device names conform to a uniform naming structure: SLS-PPP-LLLLL-N Where: "SLS" is a static string PPP = Codonics 500i product code (i.e., 060)

- LLLLL = SmartDrive license code N = "E" for Ethernet, "W" for WiFi
- Example: SLS-060-12345-W



Users should setup their Master Device List (MDL) in the same manner as they did previously using a Comma Separated Value (CSV) file with the first column being the pre-defined device name and the second column being the device name you want to represent SLS PCS. For example, SLS-060-12345-W, OR-1. For further instructions on setting up an MDL, refer to the 1.3.0 AT User's Manual.

Named Devices by default is enabled in the AT Configuration tab but can be disabled by unchecking the box.

#### **Product Improvements**

 A new Japanese small and large label version provides a "Use" date range (e.g., 02/12/2013 16:58 ~ 02/13/2013 16:58) when printed. The label template packs are selected in the Configure Locale and are JP-S1-v02 and JP-L1-v02.





- Now a single character, [希], is provided to represent the word Dilution on the Japanese small and large labels.
- Additional Lexicomp import capability is provided. The enhancements included to the Lexicomp import are:
  - An Update Matches option has been added to the Import Results dialog box to allow you to update matching drugs in addition to overwriting or skipping them.
  - All drugs added or updated during a Lexicomp import will be assigned the drug status Active so that users can control the assignment of the Obsolete status.
  - The drug status **Recall** has been added to the MDD so that recalled drugs can be more clearly identified as **Recalled**. These drugs no longer have to be assigned a status of **Obsolete** to prevent their labels from being printed.

Refer to "Lexicomp Import Enhancements" on page 30 for details.

- The AT and SLS PCS support new concentration numbers. The new numbers included are 2.25, 3.375 and 40.5.
- ◆ The AT and SLS PCS support new concentration units. The new concentration units included are ng (nanograms), ng/mL (nano-grams per milliliter) and K Units/mL (thousand units per milliliter).
- Older localization packs (i.e., 1.4.0 or newer) can now be used with newer software releases on SLS and AT. For example, JP-1.4.0 will now work with 1.5.0 software. If words or WAV files are not translated into the local language, they will default to English.
- Improved the AT-DM messaging when installing SW or packages from AT-DM to SLS PCS. The message will now indicate a progress of Transferring and then transitions to Installing. When SLS PCS reboots, the device will go Offline until the software restarts.
- Improved the Search functionality in the MDD and Formulary. Now a user can search by an exact match (i.e., is) or by a partial match (i.e., contains).





• Users now have the ability to delete dilutions and TD/TVs by clicking on the X next to the dilution or TD/TV value you want deleted from the list.

- AT passwords that were too short could cause the AT to stop working. Now, entering a new password with less than 6 characters causes the error message: Password is too short to display.
- Users can now create a formulary package of 50K drugs. Previously the AT would stop working.
- The migration tool now transfers custom audio files for drug names. You will not need to reload the custom audio files in the AT and then set each drug to the proper custom audio file.

- Selecting Enter after filling in the Package Profile name previously cleared a package build and returned the user to the main formulary page. Now when selecting Enter, a formulary or configuration package will be properly created.
- Speed improvements were made to AT operations. For example, responsiveness of the Edit Selected button and package creation time were improved.

#### **New Features**

◆ SLS PCS now supports Batch Mode. Users can now automatically print multiple copies of the same label. The label can include a defined lot number and an additional initial area for use cases where one person prepares the label and another person prepares the syringe (for example in pharmacy). A feature key is required to enable this feature. Contact your Codonics Sales Representative to purchase the key. Refer to "Batch Mode" on page 42 for complete instructions.

**WARNING:** For RBX-1-v01, users should not rely on the expiration date embedded in the SLS PCS label 2D barcode. The expiration date/time on the original label already affixed to the syringe should be used. This is because the time that the SLS PCS label was prepared will be different than when the syringe was actually filled/prepared. 3. By default, the Data Directory will be backed up every time the AT starts and when a formulary is promoted. In addition, a user can schedule automatically a backup by checking the **Every** box and selecting the day and time. Users can select how many backups to keep and where they want the backup directory to be stored. - 4. You can also search on multiple phrases with AND or OR statements. For example, you can search for Lidocaine 0.005 g/mL by setting the search field to IS and search on Lidocaine AND 0.005.
- 5. The ability to select, double-click (to select a word) and triple-click (to select all words) in the search field information is supported. You can then right click and cut, copy, paste information already contained in the search field.

**NOTE:** The same scan to search functionality works in the formulary.

 The ability to copy a drug entry in the MDD is supported. This simplifies the process for adding a new drug entry to the MDD and formulary; for example, when there is a new supply source for an existing drug.

**NOTE:** A CID is needed when using the copy functionality.

- Review all the settings for the drug. If all are correct, select Save. If there are formulary settings that need to be changed (e.g., Message), make the change and select Save. If the preview is not what you want, select Cancel and the system will be returned to the Copying Master Drug dialog box in the MDD (shown in step 2).
- When verifying a drug in the MDD, the Verify Drug screen provides new additional options. There is now the capability to search for the verified drug entry in the MDD after verifying the drug, as well as the ability to automatically add the verified drug to the formulary..

**NOTE:** The Search For Drug checkbox will be checked or unchecked based on the last setting chosen by the user for a successful verification. When unchecked, verifications are performed in a batch with one vial after another being able to be verified until completed. When checked, the AT will close the Verify Drug dialog and search for each drug upon scanning. After searching, the user must then click the Verify Drugs button to verify another drug.

**NOTE:** The Add To Formulary checkbox will be disabled if the drug being verified is already in the formulary. The AT now provides two Other options for Total ٠ Dose/Total Volume; Other - Diluted and Other - Not Diluted. The capability allows a user to configure SLS PCS to automatically display a Total Dose/Total Volume (TD/TV) drug in cases where the drug is not diluted but Other is an option in the formulary. Previously for example, a scrolling wheel would be displayed on SLS PCS with both 5 mg/10 mL and Other (with None for diluents) and a user would have to select 5 mg/10mL if they didn't want Other. Now, if the formulary has TD/TV options of 5 mg/10 mL and Other - Diluted and if a user doesn't select the Dilute switch on SLS PCS, when they scan the vial, the drug label (no scrolling wheel) will automatically display on the screen with 5 mg/10 mL as the TD/TV and ready to print.

The second verification screen on SLS (i.e., confirming the first verification screen with the question Are You Sure?) is now configurable and is set in the Configuration tab of the AT. By default, the second verification screen is checked. **NOTE:** All drug entries still need to be verified at least once. If the drug has not been verified in the AT, the first time it is scanned on SLS PCS, a verification will need to occur. The user will be prompted on SLS PCS via a dialog box to verify the drug name and concentration.

- Refresh/Stop buttons on top of AT were removed to prevent confusion. Clicking refresh would navigate back to MDD tab and clear network passwords without notice.
- Administer Mode announcement on SLS PCS is now configurable. By default, the announcement is set to on in the Configuration tab of the AT. If you do not want Administer Mode announced, then uncheck the box, create a configuration package, and deploy the package to SLS PCS.

The tallman field is now part of the information displayed when performing verification in the AT. The other fields that are displayed are CID, Drug Name, and Concentration.

# Administer Mode

# Overview

Version 1.4.0 and newer software includes support for Administer Mode with the Codonics Safe Label System<sup>TM</sup>.

This document explains how to configure Administer Mode for use with Codonics Safe Label System 500i (SLS) Point of Care Station (PCS).

An additional safety check, Administer Mode allows a SLS PCS user to scan the barcode of a syringe label that has been applied to a syringe prior to administering a drug to:

- Confirm the drug indicated on the syringe label with an audible announcement and a visual display of the drug name and concentration on the touch screen.
- Determine whether the drug in the syringe has passed its expiration date.

**NOTE:** Administer Mode requires a feature key on SLS PCS. Contact your Codonics Sales Representative to obtain the proper key.

### Configuring Support for Administer Mode

To support Administer Mode, you have to configure the Administer Mode barcode label setting in the Codonics SLS Administration Tool (AT) and then deploy the configuration package to the appropriate SLS PCS.

- 1. In the Configuration Manager section of the AT, go to the System tab.
- 2. In the SLS Label Barcode Definition list, select the definition entry with Administer Mode in its name.

# Total Dose/Total Volume

# Overview

Version 1.4.0 and newer software includes support for Total Dose/Total Volume (TD/TV) drug preparation method with the Codonics Safe Label System<sup>TM</sup>.

This document explains:

 How Administration Tool (AT) users can enter TD/TV information for drugs in a formulary

# **SLS Drug Preparation Methods**

There are two preparation methods for managing how drugs are labeled: Normal Dilution and TD/TV.

The Normal Dilution method is commonly used in OR environments where the amount and frequency of drug administration can vary. Since the total dose being administered might not be known ahead of time, the primary information required on the syringe label is the drug name and prepared concentration.

TD/TV is commonly used when an order or prescription for a drug is issued and the drug is prepared according to the instructions in the order. TD/TV is also used in applications involving infusion pumps. Drugs prepared in this manner include the drug name, the total dose to be administered, and the total volume of the drug and diluent in the final preparation. Safe Label System 500i (SLS) Point of Care Station (PCS) also includes the equivalent concentration of the preparation on the label for regulatory compliance.

SLS allows multiple TD/TV preparations to be associated with each drug. The preparations are set up using the AT and included as part of the SLS formulary. When a drug container is scanned on SLS PCS, the user can select from the TD/TV preparations associated with that drug.

# Notes About the TD/TV Preparation Method

Note the following about the TD/TV preparation method:

 The TD/TV information will be printed on labels that support it [for example, 30 x 80-mm Japan labels (JP-L1\_vxx)] and shown on any applicable previews.

However, if the selected drug classification template does not support TD/TV information, the TD/TV dialog boxes described in this Technical Brief will still appear on SLS PCS, but the label will not have any TD/TV information printed on it.

- TD/TV information is not encoded in the syringe barcode.
- The TD/TV function is only supported for single drugs in the formulary. It is not supported for combination drugs.
- Administer Mode will only announce the drug name and equivalent concentration, but not the TD/TV values.

## On the AT-Setting the Always Show TD/TV Option

The Always Show TD/TV option, which is located on the Safety tab of the AT's Configuration Manager section, controls when the TD/TV prompt displays during the label printing procedure on SLS PCS.

**NOTE:** The Always Show TD/TV option applies only to drugs that are assigned the TD/TV preparation method. For drugs that are assigned the Normal Dilution preparation method, the prompt for dilutions and diluents works as described in the SLS User's Manual.

### Always Show TD/TV option

- If the Always Show TD/TV option is selected (the default), the TD/TV prompt will always display during the label printing procedure on SLS PCS.
- If the Always Show TD/TV option is deselected, then the TD/TV prompt will not display if there is only one TD/TV entry and one diluent. In that case, the procedure will go directly to displaying or printing the label.



To disable the Always Show TD/TV option, you must deselect the option, create a configuration package, and deploy the configuration to each SLS PCS.

## On the AT-Specifying TD/TV Entries for a Drug in the Formulary

The following procedure covers only the drug formulary settings that are specific to TD/TV. For more information about other drug formulary settings, refer to the SLS Administration Tool User's Manual.

1. Select the Label Template Pack that you want to create for the specific formulary.

All Label Template Packs support TD/TV if the drug's preparation method is set to TD/TV:

- The JP-L1 Label Template Pack supports printing of TD/TV on the label.
- The JP-S1 and STD-1 Label Template Packs will show TD/TV on the SLS PCS user interface but not print TD/TV on the label.

For more information about the Label Template Packs, refer to "Localization Enhancements" on page 23.

2. With the formulary drug list displayed, click the drug record's Edit icon.

# Localization Enhancements

### **Overview**

Version 1.4.0 and newer software for Codonics Safe Label System<sup>TM</sup> (SLS) Administration Tool (AT) includes enhancements to the localization functionality:

- Label template packs can be loaded and managed to support local requirements for label sizes and formats
- Large and small format label templates are now available
- Barcode parsing rules can be created to support local barcode encoding formats

**NOTE:** This Technical Brief includes the user interface updates that are provided in Version 1.5.0 or newer software.

# Label Template Management

#### Label Template Packs

Label template management is based on the use of Label Template Packs, which are Zip files that contain a complete set of templates as well as the information required for the template pack to be installed and operated in the AT.

The drug classification templates in a template pack have the same size and are used to address the label requirements for a locale.

Label template packs are only developed and released by Codonics.

#### Label Template Pack Zip File Naming Convention

Label template pack Zip files use the following naming convention:

- A region identifier. This will typically be a country code (for example, JP for Japan), but can also be other codes such as STD (for the SLS standard template pack based on the ASTM 4774 standard) and DIVI (for German DIVI templates).
- A unique identifier for packs in the same region (for example, -1 or -2).
- A version number (for example, v01).

Examples of template pack names are:

- STD-1-v01.zip, for the standard SLS pack 1, version 1
- JP-L1-v01.zip, for Japanese large format pack 1, version 1

#### Installing a Label Template Pack

To install a template pack:

1. Click the Configure Locale button at the bottom left corner of the Formulary tab.

## Large and Small Format Labels

Version 1.4.0 and newer software included two new sets of syringe label templates: a large and a small format.

For examples of the medium format syringe label templates that are available with previous software releases, refer to the SLS Administration Tool User's Manual.

**NOTE:** The template pack is selected for each formulary. Create a formulary package and deploy the formulary package to SLS devices. For information about creating and deploying formulary packages, refer to the SLS Administration Tool User's Manual.

**NOTE:** Make sure that the correct size labels are loaded on SLS PCS for the template pack selected. If the wrong label size is installed (for example, a large template was selected but small labels are installed, ink will overspray in SLS PCS).

#### Creating Separate Formularies with Large and Small Label Formats

To create separate formularies that include the same drugs but use large and small labels:

1. In the **Configure Localization** dialog box, select the large label format as the active Label Template Pack.

When changing the active Label Template Pack, the following warning message displays. It explains that some drug classifications in the formulary might not be supported by the selected Label Template Pack. You have the option of resetting the drug classification for those drugs to **None**, or resetting the drug classifications for all drugs in the formulary to Miscellaneous White Label.



**NOTE:** This message is displayed whether there are drugs in the formulary or not.

- 2. Select the appropriate reset option:
  - a. To reset the drug classification for all drugs in the formulary to Miscellaneous White Label, click the **Reset All** button.
  - b. To reset the drug classification to None for only those drugs in the formulary whose classifications are not supported by the selected Label Template Pack, click the Reset Only Missing Templates button. If you click this button, you are prompted to confirm this selection.

#### Change Label Template Pack



Click the OK button to confirm the selection of this option.

- 3. Review the drug classifications that were changed based on the chosen reset option and set them as appropriate for the Label Template Pack that you selected.
- 4. Create the formulary package that will use the large label format.

**NOTE:** You can assign a name to the formulary package that indicates what label format was specified for it.

- 5. Close the AT.
- Make a copy of the AdminTool-Data directory and rename it (for example, AdminTool-Data-Small-Label).

**NOTE:** You create unique formularies when using different label sizes because it is common for the set of drugs that will use small labels to be different than the set of drugs that will use large labels.

# 

- 7. Restart the AT.
- 8. During startup, when you are prompted to locate the data directory, select the directory copy that you made and renamed (for example, AdminTool-Data-Small-Label).
- 9. In the Configure Localization dialog box, select the small label format as the active Label Template Pack.
- 10. Repeat steps 2 and 3 above to select a reset option and review the drug classifications that were changed.
- 11. Create the formulary package that will use the small label format.

### Large and Small Format Label Examples

Examples of the large and small format syringe label templates are shown below.

**NOTE:** The syringe label properties of the drug classification templates, such as background color, primary stripe color, and label pattern, are the same for all label formats, regardless of the format size. For a list of sample labels for each of the label templates, refer to the SLS Administration Tool User's Manual.

# **Barcode Parsing Rules**

The Barcode Parsing Rule function allows you to create parsing rules to support barcode encoding formats that are not included in the standard release of the software. A barcode parsing rule specifies which characters in the barcode constitute the Container ID.

### **Creating a Barcode Parsing Rule**

Before attempting to create a barcode parsing rule, obtain the information about the encoding format for the barcode that you want to use. To simplify the rule creation process, you should also have a sample barcode with the proper encoding format to scan.

**CAUTION:** Until you are thoroughly familiar with entering barcode parsing rules, only perform the following procedure under the direction of Codonics Technical Support.

To create a barcode parsing rule for a barcode encoding format:

1. Click the Configure Locale button at the bottom left corner of the Formulary tab.

#### Setting the Order of Barcode Parsing Rules

When a barcode is scanned from the AT or SLS PCS, the system first identifies the barcode's symbology. It then applies the barcode parsing rules in their order of priority looking for a match. When a match is found, the system identifies the Container ID within the code.

To change the priority order of the barcode parsing rules, in the **Configure Barcode Parsing** dialog box, click and drag a rule entry to a different position in the list.

## Database Mode in the Configure Localization Dialog Box

In Version 1.4.0 AT software, the functionality of the **Database Mode** list selection changed. It no longer controls how barcodes are parsed; that is, handled by the Barcode Parsing Rules function. Now, **Database Mode** only determines whether the Master Drug Database (MDD) is in US NDC or Other mode.

# Lexicomp Import Enhancements

# Overview

Version 1.5.0 and newer software for Codonics Safe Label System<sup>TM</sup> Administration Tool (AT) includes enhancements to the Lexicomp import function:

- An Update Matches option has been added to the Import Results dialog box to allow you to update matching drugs in addition to overwriting or skipping them.
- All drugs added or updated during a Lexicomp import will be assigned the drug status ACTIVE so that users can control the assignment of the OBSOLETE status.

**NOTE:** Starting in 1.7.0 SW, when importing from a Lexicomp database, a drug's status field will be set to **OBSOLETE** in the MDD if the drug's end of manufacture date is prior to the Lexicomp database creation date. In addition, when importing into the AT via the **Update** action, the status field will not be updated if a drug in the AT is already edited, in the formulary or verified.

 The drug status Recall has been added so that recalled drugs can be more clearly identified as Recalled and no longer have to be assigned a status of Obsolete to prevent those labels from being printed.

### Lexicomp Import Behavior Prior to Version 1.5.0

In software versions prior to version 1.5.0, when Lexicomp data was imported into an existing Master Drug Database (MDD), the AT identified drug matches based on the Master ID (i.e., the 11-digit NDC value).

The AT user then had two options: either overwrite all matching entries or skip importing all matching entries.

If the **Overwrite Matches** option was chosen, the following fields were overwritten (i.e., all fields except Tallman and Verification):

- Drug Name or Combination Drug Name
- Container ID
- Concentration (number and units), or Combination Concentration (number and units)
- Route
- Status

Both the Overwrite Matches and Skip Matches options always added new (non-matching) drugs.

To apply potential Lexicomp updates, the AT user would select the **Overwrite Matches** option, potentially undoing local edits to the drug records in the MDD.

To avoid undoing drug edits in the MDD, the user would select the Skip Matches option. However, this would cause some updates to be missed, such as to 10-digit Container IDs.

# **Update Matches Option**

In version 1.5.0, the Lexicomp import function now includes an Update Matches option. This option allows you to update matching drugs when performing a Lexicomp import, rather than just overwriting or skipping the drugs. This provides a more intelligent update to the MDD, based on Lexicomp updates and the state of the MDD.

**NOTE:** The Update Matches import option is only available for Lexicomp imports. CSV imports do not support this function.

# Which Drugs Will Not Be Updated

When selecting the **Update Matches** option, drugs with the following conditions will not be updated:

- Drugs that have already been verified, since their data has already been confirmed during the verification step.
- Drugs in the MDD that have been edited, so that edits are retained.
- Drugs in the formulary.

However, even for drugs with these conditions, if you select the **Update Matches** option during the Lexicomp import, the following will be updated:

- The Route value, so you can correlate drugs in the MDD with the import filter used to import them from Lexicomp.
- The Container ID value if it has not already been assigned in the MDD. This eliminates learning before verifying a drug on the AT and eliminates learning a drug on the SLS.

### When Drug Records in the MDD Are Considered Edited

A drug entry in the MDD will be considered edited if any of the following conditions are true:

 The drug entry was manually created by a user via Learn mode or manual text entry (i.e., not via Lexicomp import).



- The drug entry was imported from a CSV file.
- Any of the drug data was manually edited and saved (except Tallman data).

#### **Database Migration and the Edited State**

When a database (MDD and formulary) is migrated from a previous version to version 1.5.0, all of the drugs in the MDD will be considered and set to an Edited state. This is because it is impossible to know in databases from previous versions whether a drug has been edited or not.

#### Lexicomp Imports and the Edited State

Once migrated, and then after a Lexicomp import is performed, drugs in the MDD that have the same attributes as in the Lexicomp database will be considered and set to an Unedited state. This is because when the MDD values match what is in Lexicomp, the system determines that the drug records in the MDD have not been edited.

Similarly, any drugs that are selected for **Overwrite Matches** will be considered Unedited, since they will also match the Lexicomp database attributes after the import is completed.

#### CSV Imports and the Edited State

After a CSV import, all drugs that are added or overwritten will be considered Edited, since CSV importing is considered to be similar to manual editing.

# **Performing an Update Matches Import**

When importing Lexicomp data using the AT, the Import Results dialog box includes an Update Matches button, as shown below.

You can use this information to determine which drugs have been edited in the MDD or added to the formulary and, therefore, could be affected by choosing the Update Matches option.

**NOTE:** The Pre-Import Report contains the Lexicomp values for all the drugs considered for import, so it is a valuable reference for manually reconciling any drugs post-import that were not completely updated.

After reviewing the Pre-Import Report, if you select the Update Matches option, the following will occur:

- All new drug entries will be added to the MDD.
- Existing drug entries that are verified in the MDD will not be updated.
- Drug entries that have Yes entered in the Edited column or Yes entered in the Is In Formulary column will be updated but will have only their Container ID value filled in, if not already filled in, or their Route value updated if the route has changed.
- Drug entries that have No entered in the Edited column AND No entered in the Is In Formulary column will be updated for all attributes (except Tallman and Status) in the MDD with any different values from Lexicomp for those drugs.

You can use this information to determine which drugs had been previously edited in the MDD or added to the formulary. You might want to manually edit these drugs to restore drug information that had been manually added or changed prior to the Lexicomp import.

If you had selected the **Update Matches** option, all new drug entries in Lexicomp will be added to the MDD. In addition, the Post-Import Report will include status messages for the following cases when drug entries in Lexicomp matched drug entries in the MDD:

 Drug entries that were verified in the MDD will not have been updated. The following message will be included in the report for these drug entries:

Matching drug was skipped during import because it was already verified.

Since you had previously verified the drug information (drug name, drug concentration, and Container ID) against an actual container, no further action for these drug entries is suggested.

 Drug entries that were not previously verified and now have Yes in the report's Edited column or Yes in the Is In Formulary column will have been partially updated but will have had only their Container ID value entered (if not already entered) or their Route value updated (if it was changed). The following message will be included in the report for these drug entries:

Matching drug was partially updated during import.

- If Yes is entered in the Edited column, then there is a difference in the drug entry between the MDD and Lexicomp. If Yes is entered in the Is In Formulary column, check the drug entry to make sure that its data is correct. A formulary report can be generated to evaluate the data and compare it to the Pre-Import Report, which contains the Lexicomp values for all of the drugs that were partially updated.
- Drug entries that have No in the report's Edited column AND No in the Is In Formulary column will have been updated for all attributes (except Tallman and Status) in the MDD with values from Lexicomp. Therefore, these drug entries will now be the same for the MDD and Lexicomp. The following message will be included in the report for these drug entries:

Matching drug was updated during import.

You should evaluate these drug entries if you are going to add the drug to the formulary.

# **Changes to Drug Status Settings**

In versions prior to version 1.5.0, the Lexicomp drug status values, Active or Obsolete, were included in the imported drug information. However, there was an issue with this approach: Given only the two statuses Active and Obsolete, users were not able to indicate that a drug had been recalled. To prevent the label of a recalled drug from being printed, users had to assign a status of Obsolete to it, causing potential confusion about a drug's actual status.



To address this issue, the following enhancements to the drug Status settings are included in version 1.5.0:

• All drugs being imported during a Lexicomp import will be assigned a status of ACTIVE. Any existing drug entries in the MDD will no longer have their Status value altered as the result of a Lexicomp import.

**NOTE:** Starting in 1.7.0 SW, when importing from a Lexicomp database, a drug's status field will be set to **OBSOLETE** in the MDD if the drug's end of manufacture date is prior to the Lexicomp database creation date. In addition, when importing into the AT via the **Update** action, the status field will not be updated if a drug in the AT is already edited, in the formulary or verified.

 In addition to the ACTIVE and OBSOLETE drug statuses, a RECALLED status is now supported and can be set in the MDD, as shown in the following Editing Master Drug(s) dialog box.

The Safe Label System 500i (SLS) Point of Care Station (PCS) handles drugs with a RECALLED status the same way that it handles drugs with an OBSOLETE status; that is, by not printing the label and displaying and announcing the following message:

Drug not approved for use.



# Auxiliary Barcodes

# Overview

Version 1.5.0 and newer software for Codonics Safe Label System<sup>TM</sup> (SLS) includes support for Auxiliary Barcodes on standard size labels.

Auxiliary barcodes can be included on printed standard size syringe labels to encode the Container ID number of the original drug container.

Auxiliary barcodes can contain:

- A 10-digit Container ID when the SLS Master Drug Database (MDD) mode is set to US NDC.
- A 10- or 13-digit Container ID when the SLS MDD mode is set to Other.

Only the original Container ID of the drug container will be encoded in the auxiliary barcode.

Currently, only 1D barcodes are supported for auxiliary barcodes.

## **Configuring Support for Auxiliary Barcodes**

To support auxiliary barcodes, they must be configured in the SLS Administration Tool (AT). Then, the configuration and formulary packages must be deployed to the appropriate Safe Label System 500i (SLS) Point of Care Stations (PCS).

To configure auxiliary barcodes:

- 1. In the Configuration Manager section of the AT, go to the System tab.
- 2. In the Auxiliary Barcode list, select the desired auxiliary barcode option.



 No Barcode - No Write-In Area. An area for an auxiliary barcode will not be included on the syringe labels.



• No Barcode - Patient Name Write-in. A blank area will be included on the syringe labels for information such as patient name to be manually written in.



 10 digit NDC Barcode (EAN-13). A 10-digit auxiliary barcode that includes the Container ID will be included on the syringe labels.



 13 digit GTIN Barcode (EAN-13). A 13-digit auxiliary barcode that includes the Container ID will be included on the syringe labels.



If you choose an option other than No Barcode - No Write-In Area, a dialog box displays that indicates that the auxiliary barcode requires that an appropriate label template be selected. Click the OK button to close the dialog box.

3. Modify other configuration settings as needed and create the configuration package. For more information about the other configuration settings and how to create a configuration package, refer to the SLS Administration Tool User's Manual.



If you chose an option other than **No Barcode - No** Write-In Area, go to step 4 to select the auxiliary barcode label template pack.

If you chose the No Barcode - No Write-In Area option, you have finished the procedure.

- 4. Go to the Formulary tab.
- 5. Click the Configure Locale button at the bottom left corner of the Formulary tab.

**NOTE:** If the label template pack selected for a configuration package does not include support for the auxiliary barcode, and an auxiliary barcode was selected in the System tab in the AT, then the barcode will not print on the syringe labels. No errors or warnings will be displayed on SLS PCS.



## Auxiliary Barcode Warnings in the Formulary Report

The formulary report in the AT includes a **Barcode Compatibility** tab that will display warning messages for each drug that has a Container ID that is not 10 digits or 13 digits, or that includes non-digit characters.

You can continue promoting and deploying a formulary package even if barcode compatibility warnings exist in the formulary report.

# **Auxiliary Barcode Labels**

The label template pack for auxiliary barcodes is STD-2. The standard size for auxiliary barcode labels is 22 x 60 mm.

The barcode symbologies are EAN-13 and UPC-A.

### **Barcode Location on Labels**

The auxiliary barcode will be located on the lower left portion of the label, opposite of the primary barcode, as shown in the example label below.



The primary and auxiliary barcodes are separated to minimize accidental reading of the wrong barcode. To prevent scanning of the auxiliary barcode when performing Administer Mode on SLS PCS, it is recommended that you cover the auxiliary barcode with your finger prior to scanning on SLS PCS.

**WARNING:** Scanning the auxiliary barcode in Administer Mode or when the SLS PCS main screen is displayed will create another label. If creating this label was unintended, either cancel the label's printing at the pre-print confirmation screen or discard the label.

#### Printing a Placeholder Graphic for a Non-Compliant Container ID

If SLS PCS detects that a drug's Container ID is not compliant with the 10-digit or 13-digit limit, it will print a label with a special "X" graphic, as shown in the example below.



For example, the last digit of a 13-digit Container ID must be a check digit for the rest of the Container ID. If it is not, then the Container ID will be non-compliant.

SLS PCS will not display any error or warning messages when non-compliant Container IDs are encountered. The placeholder graphic will act as the only indicator to the user that the drug Container ID is not compatible with the auxiliary barcode.



# Variable Length Container IDs

## **Overview**

Version 1.5.0 and newer software for Codonics Safe Label System<sup>™</sup> (SLS) supports scanning and reading of variablelength Container IDs. For example, Safe Label System 500i (SLS) Point of Care Station (PCS) will now scan a drug container that uses a Data Matrix barcode with a 10-digit Container ID and a completely different container that uses an EAN-13 barcode with a 13-digit Container ID.

Previous releases supported only one predefined Container ID (that is, 10-digit) in a formulary. In version 1.5.0, Container IDs can be from 1 to 18 digits in length within a specific symbology (e.g., Data Matrix) or across symbologies (e.g., a 10-digit Container ID Data Matrix and a 13-digit EAN-13). This allows SLS to support scanning drug containers and printing syringe labels in sites that:

- Source drugs from multiple countries that have different standards for defining Container IDs.
- Use a combination of pre-labeled drugs and over-labeled drugs that have different length Container IDs and different symbologies.
- Prepare their own medications (compounding) and label the compounded drugs in the pharmacy with hospitalunique pharmacy ID codes as well as use prepared medications in vials and ampoules.

NOTE: Container IDs greater than 15 characters are not guaranteed to fit in the standard syringe barcode, depending on the format of the data they contain. However, if the data is mostly numeric or follows a welldefined pattern, then it is likely to fit. Otherwise, another field from the syringe barcode has to be removed to accommodate the long Container ID. In those cases where the Container ID is greater than 15 and less than 18 characters and does not fit the standard numeric or well defined pattern, a Custom Barcode Definition could be created and added to the Safe Label System<sup>™</sup> (SLS) Administration Tool (AT). This definition is part of the configuration package, and applies to all drugs in the formulary of a SLS PCS on which such a configuration has been applied. Contact Codonics for further instructions.

## Barcode Length and Container ID Length

The length of a barcode is not necessarily the same as the length of the Container ID that it contains. For example, a Codonics Container Labeling System<sup>™</sup> (CLS) barcode can contain the Container ID as well as expiration and lot information. The barcode length can be 20 or more characters; however, the Container ID portion of the barcode might only be 10 or 12 characters.

In version 1.5.0, barcode parsing rules can accommodate printing barcodes that include the Container ID and additional information. The barcode has a practical limit of 35 characters.

# **Configuring Container ID Lengths**

To configure a range of Container ID lengths to be supported:

- 1. In the Configuration Manager section of the AT, go to the System tab.
- 2. In the Primary Barcode Definition list, select option 4.

## Barcode Parsing Rules and Variable-Length Container IDs

The following topics describe how barcode parsing rules are used to support variable-length Container IDs. For more information about creating and managing barcode parsing rules, refer to "Localization Enhancements" on page 23.

#### Barcode Parsing Rules and Finding Matching Container IDs

In version 1.5.0, when parsing a scanned barcode during the Container ID matching process, the system uses a "Match All Rules" approach. This means that the system must compare an incoming barcode with all possible parsing rules. If there are multiple matches and thus multiple possible Container IDs, the system allows the user to choose which match is correct.

For example, let's say that the barcode parsing rules include the following two rules:

#### Rule 1:

Match = 01#### Transfer = --++++ (Container ID = 4 digits)

#### Rule 2:

Match = ###### Transfer = ++++++ (Container ID = 6 digits)

With these rules, any 6-digit barcode that starts with **01** will match the first rule and will generate a 4-digit Container ID. However, there may be a barcode that starts with **01** that is a legitimate 6-digit barcode intended to match Rule 2.

So, using these sample rules, a barcode string of **012345** would match both rules and would generate two possible Container IDs:

• Container ID = 2345 (from Rule 1)

Container ID = 012345 (from Rule 2)

On SLS PCS, both Container IDs would be compared against the formulary. If there were more than one match, then the user would have to choose between the matches (similar to when there are multiple instances of a single Container ID in the formulary). However, if only one match is found, then it would be assumed to be correct and the user would not be prompted to make a choice.

#### **Example Barcode Parsing Rules**

The set of barcode parsing rules listed in the following Configure Barcode Parsing dialog box includes examples of rules for variable-length Container IDs.

The following example Edit Barcode Parsing Rule dialog box shows the details of the first rule in the list above. In this example, there is a prefix of **010** that identifies the matching barcode/rule, and then the following 13 characters comprise the Container ID. Therefore, the total barcode length is 16.





#### **Barcode Parsing Rules and Verification**

Because the barcode parsing rules determine how a scanned barcode is interpreted, and thus what its corresponding Container ID is, any changes to the rules might invalidate drugs that have already been verified in the AT. For example, a rule could be edited or superseded by another rule that would cause a particular container barcode to be interpreted differently, resulting in a different Container ID or in the drug not being found when the container is scanned.

As a result, when the barcode parsing rules are **modified** and/or **deleted**, drugs in the Master Drug Database (MDD) might need to be unverified and then re-verified. However, because re-verifying all drugs in the MDD can take substantial time and effort, the AT allows the user to choose to unverify all the drugs or not.

When a barcode parsing rule is **added**, the only possible effect on existing drugs would be another potential match based on the new rule. The "Match All Rules" behavior already accommodates this scenario, so adding a new barcode parsing rule does not require re-verifying drugs.



# Batch Mode

# Overview

Version 1.6.0 and newer software includes support for Batch Mode with the Codonics Safe Label System<sup>™</sup> (SLS).

Batch Mode allows a Safe Label System 500i (SLS) Point of Care Station (PCS) user to automatically print multiple copies of the same label. The label can include a user defined lot number and a larger initial area for use cases where two sets of initials are required on the label. This may occur because a different person prepared the label than prepared the syringe or in a case when a second check for safety is required (for example in pharmacy).



**NOTE:** Batch Mode requires a feature key on SLS PCS. Contact your Codonics Sales Representative to obtain the proper key.

**WARNING:** The safest means to label a syringe (or any container of medication) using SLS PCS is to scan a vial or ampoule, draw up the drug as the label is being printed, and then immediately label the syringe before setting it down. Batch Mode introduces the risk of a mislabeled syringe since more than one label from a single vial/ampoule scan is being created, changing the one-to-one relationship (e.g. one vial and one syringe with a single label). For example, if there is more than one filled syringe without a label, there is a potential for a syringe to be mislabeled. Or if there are more labels than there are filled syringes, there is a potential for a rogue label to be placed on the wrong syringe. Be sure to visually confirm the label you are applying is the correct one for the syringe being labeled.

# **Configuring Support for Batch Mode**

To support Batch Mode, enable the Batch Mode setting in the Codonics Safe Label System<sup>™</sup> SLS Administration Tool (AT) and deploy the configuration package to the appropriate SLS PCS. By default, Batch Mode is disabled.

**NOTE:** Before starting a batch job of strips or many single cuts (e.g., greater than 15 labels), consider if and how you want them to be collected to prevent having them collect on the floor or backing up into SLS PCS.

- 1. In the Configuration Manager section of the AT, go to the Safety tab.
- 2. Uncheck Disable Batch Mode.



 By default an additional initial area is included on the label for labels (i.e., standard and large) that include preparer's initials. Go to the System tab and uncheck the Enable extended initials area if not required.

# Workflow Improvements overview The following are reco

Version 1.8.0 and newer software for Codonics Safe Label System (SLS) Administration Tool (AT) includes workflow improvements for updating formularies. These new enhancements include:

- Reporting drug Verifications that occurred on SLS Point of Care Stations (PCS) back to the AT.
- Reporting Drug Not Found (DNF) events that occurred on SLS PCS back to the AT.
- Identification of drugs in the SLS Formulary that have not yet been edited (i.e., Unedited).
- Smart Copy of DNF drugs or newly added drug(s) to the formulary.

**NOTE:** A hand scanner, preferably the one used for adding and verifying drugs in the AT, should be connected to the personal computer (PC) running the AT for managing verification and Drug Not Found processes.

**NOTE:** If the AT was closed, in order to receive the latest updates from SLS PCSs, log into the AT, go to the AT Device Manager, open up the MDL, and connect to the SLS PCSs.

# **Drug Verification**

Previously, the AT user wouldn't be able to immediately know when a drug that was not verified in the AT was verified on an SLS unless they were told or they received notification from Email Notifier.

Now when a drug is verified on SLS PCS rather than on the AT, the verified drug information is sent back to the AT letting the AT user know of the issue. To support this improved workflow, the AT Formulary tab now has a Verifications tab and Verification Events groups.

**NOTE:** With this verification information, the AT user can update the existing formulary and distribute a new formulary package to all SLS PCSs so that other SLS PCS users do not also have to verify the same drug that had been verified on a different SLS PCS.

For those SLS PCSs that aren't updated, when a subsequent verification occurs, they will report back to the AT and add the specific formulary package number to the drug entry whether it is in the SLS Verified or Resolved group.

The following are recommended workflows for different use cases to process drug verification(s) that have occurred on SLS PCS and been reported back to the AT.

**NOTE:** If a verification event is identified, the AT user should obtain the container(s) associated with the event.

# Use case: A drug is verified on SLS PCS because it was not verified in the AT

1. When a drug is verified on SLS PCS, the AT will display information for that drug in the SLS Verified filter. It will show the Date/Time of the verification, the formulary in which the drug entry exists, and all the information defined for the drug in the MDD including Drug Name, Master ID (MID), if available, and the Container ID (CID), highlighted in yellow. The AT screen looks like:

**NOTE:** For those SLS PCSs that aren't updated, when a subsequent verification occurs, they will report back to the AT and add the specific formulary package number to the drug entry whether it is in the SLS Verified or Resolved group.

#### Use case: Drugs that fail verification on SLS PCS

- 1. When a drug fails verification on SLS PCS, the AT will display information for that drug in the Failed verification filter. There it will report the Date/Time of the failed verification, the formulary in which the drug entry exists, and all the information defined for the drug in the MDD including Drug Name, MID (if available), and the CID, highlighted in red.
- 2. Review the drug information and find the container that was scanned that caused the failed verification.
- 3. It is possible that either the information in the formulary is incorrect (e.g., drug name, concentration, concentration units) or there is another drug that has the same CID.



- 4. If the information in the formulary is incorrect, update the formulary and deploy it to all SLS PCSs.
- 5. If it is another drug (e.g., name, concentration) with the same CID, then the second drug (along with all its drug information) should have its own drug entry entered in the MDD and formulary with the same CID as the first drug. The formulary should be deployed to all SLS PCSs. Once both drug entries are in the formulary, SLS PCS will ask a user which of the two drugs it is each time a container with this same CID is scanned.

# Use case: Ignoring drugs that are verified on SLS PCS (successfully or failed)

1. If there is a drug entry that you do not want to verify in the AT, you can select the ignore icon in the Actions column.



- 2. You will be asked to confirm that you want to move the drug entry to the **Ignored** filter. Select **Yes**.
- 3. The drug entry will be moved to the Ignored filter.

**NOTE:** Drug entries that are **Ignored** will remain in the filter for 60 days and then purged.

#### Drugs verified with 1.7.0 or older software

For drugs that were verified on an SLS PCS with 1.7.0 or older software within 30 days of upgrading SLS PCS to 1.8.0, only the CID will be reported back to the AT.

- 1. The AT will determine if there are any matching drugs (i.e., CID matches). If the CID of the verified drug matches a single CID in the MDD, the AT will automatically populate the drug information in the drug entry. If there is not a single match, the AT will only show the CID, highlighted in red.
- 2. If there is not a single match, the AT will only show the CID that was scanned on SLS. In this use case, you should click the select icon.



- 3. If there isn't an exact match, but there are 10 to 11 digit MID mappings, then the AT will display the mapping option(s) for the user to review and select.
- 4. If you select a mapped drug, the AT will automatically populate all the drug information on the Edit Drug dialog and prompt you to Save the drug information (including the CID) in the MDD. The AT will then return you to the SLS Verified group with all the information now filled-in for the drug.
- 5. Review the drug entry information.
- 6. Follow the steps starting with step 3 in the previous section, Use Case: A drug is verified on SLS PCS because it was not verified in the AT.

# **Drug Not Found**

When a drug is not in the formulary and a SLS PCS user scans the drug container on SLS PCS, a Drug not found (DNF) message is displayed on the SLS PCS. A user has always been able to print a custom Blank label to ensure proper labeling of a syringe. Now the DNF information is sent back to the AT Formulary letting the AT user know of the issue.

**NOTE:** With this DNF information, the AT user can update the existing formulary and distribute a new formulary package to all SLSs so that other SLS users do not experience a DNF issue for the same drug.

For those SLS PCSs that aren't updated, when a subsequent DNF occurs, they will report back to the AT and add the specific formulary package number to the drug entry(ies) whether it is resolved or still unresolved.

To support this workflow, the AT Formulary tab now has a DNF tab and a Drug Not Found Events group. Now when a DNF on SLS occurs, the SLS will report the CID to the DNF tab in the AT. Clicking on the Unresolved group displays an entry with the available information.

When a drug is added to the SLS Formulary (whether it is manually from the MDD, from the verification process, or from the DNF process previously discussed), but you haven't edited the entry's drug settings (e.g. drug classification template, message, dilution, diluents etc.), a new workflow improvement has been added to easily find those drugs.

Now, the SLS Formulary tab has a Formulary Drug Filters group and an All and an Unedited filter. To easily find those drug entries that have not yet been edited, click the Unedited filter which will display each drug in the formulary which has not yet been edited.

**NOTE:** Once the drug is edited, the entry is updated and displayed in the **Unedited** list but no longer highlighted in yellow. The entry remains in this filter until you click over to another filter or tab. You can edit the drug again at any time.

It is recommended that you complete all your edits on a drug before clicking on another filter or tab because this will be the easiest way to see which drug(s) you have been editing.

## **Smart Copy**

To aid in editing drugs that have been added to or are already in the formulary, a new workflow improvement, Smart Copy, has been added.

Smart Copy allows you to copy formulary settings from an already-edited drug with the same name and concentration so that settings do not need to be manually entered for each formulary drug.

A new icon for Smart Copy was added to the Actions column of the formulary and to the Edit selected buttons at the bottom of the formulary.

1. Select the desired drug entries that have the same name and concentration.



- 2. Click the Smart Copy icon.
- A dialog box will be displayed. You will be asked whether you want to see all the matching drugs already in the formulary or whether you want to copy the first matching drug in the formulary.

4. If you click **See Matches**, all already-edited formulary drug entries that have matching drug name and concentration as the selected drug(s) will be displayed.

- 6. The Smart Copy Editing Formulary Drug(s) dialog will be displayed showing all the settings for the edited drug selected in step 5 that will be applied to the unedited drug(s). Saving (and possibly changing) these settings will not affect the edited drug selected in step 5. It will only affect the drug(s) selected for Smart Copy.

 Review all the settings (e.g., Drug Classification, Message, Audio, Expiration Time etc.) and make any modifications to the drug entry. When done editing, click Save to update the drug(s) selected for Smart Copy.

**NOTE:** Any changes made on the **Smart Copy Edit** dialog, for example adding a message, will NOT affect the edited drug that you have copied from step 5.

8. The selected entries are updated. If you remain on the Unedited filter, previously unedited entries are now no longer highlighted in yellow. The entry remains in this filter until you click over to another filter or tab. You can edit the drug again at any time.
